ADDITIONAL CONDITIONS OF THE CONTRACT

Cancellation- Artist is not bound to this agreement if the sponsor does not honor the agreement unless agreed in writing with Artist. Any attempt to alter the terms or concept of this contract with Artist will result in a breach, unless approved in writing. Deposit is non-refundable. Cancellation notices must be in writing; otherwise the sponsor will be obligated for the honorarium. Sponsor is responsible for 100% of any non-refundable travel costs. If sponsor cancels within three (3) months of event, sponsor agrees to pay 50% of honorarium. If sponsor cancels within one (1) month of event, sponsor agrees to pay 100% of honorarium.

Sponsor agrees that Artist may cancel this engagement if travel expenses set forth in this contract are not paid by due date or prior to travel departure date for event.

In the event of cancellation of this agreement by the Artist due to illness or an unforeseen emergency, or overriding obligations or professional responsibility, Artist will not have any liability for expenses or losses incurred by the Sponsor. Artist will attempt to provide a comparable Artist that is acceptable to the Sponsor.

This agreement to perform on behalf of said Artist is subject to reasonable detention or absence by reason of sickness, accidents, difficulties with transportation, riot, strikes, epidemics, weather, acts of God, or any other reasonable conditions beyond the control of the Artist.

The engaging organization agrees to maintain the absolute confidentiality of all the terms, conditions, and arrangements contained herein and/or associated with this appearance.

Engagements to be rendered pursuant to this agreement shall not be recorded, reproduced, or transmitted from the place of the performance in any manner, audio or video, or by any means, without an additional specific written agreement.

The Sponsor acknowledges and represents that he/she has the authority to enter into this agreement on behalf of the persons set forth on the opposite side of this agreement, and where he is not acting as agent, he represents that he is in good standing to make the warranties made by him in this agreement. The persons executing this agreement on Sponsor's behalf warrants his authority to do so, and such person hereby personally assumes liability for the payment of said price in full.

Sponsor agrees that Artist Rider is part of this contract. *(If Rider not received, please notify Artist.)*

Any additional provisions to this agreement shall be attached by addendum. Unless agreed to at the signing of contract, no radius clauses shall be granted.

Sponsor shall provide a sound system with a minimum of sixteen (16-24) channels, multi-effects unit for vocals, Drum microphones (Kick, Snare, Toms, overhead), three (3) vocal microphones with boom stands, two (2) guitar amp microphones, four (4-5) monitors with (3-5) separate mixes, CD player or iPod, and a technician capable of running same. The technician should have system ready for sound check at the predetermined time. If Sponsor is unable to provide above equipment, please inform Artist ASAP so that other arrangements can be made.
